4. I /We represent and warrant to the Releasees that I/we have not been advised by the Government of Canada or Ontario Public Health or my/our doctor or the Ontario Ministry of Health website to self-isolate due to possible exposure to COVID-19.
5. I am/ We are fully aware of the risks and hazards with respect to COVID-19 inherent in my/our attendance at the Premises and participation in the activities of the Campground.
6. I/We freely and voluntarily agree to assume the risk with respect to COVID-19, including the risk of death, bodily injury or property damage, regardless of severity, that I /we may sustain as a result of my participation in the activities of the Campground or attendance at the Premises, howsoever arising, including, but not limited to, the active or passive negligence of the Releasees.

I/We understand that there are inherent and unforeseen risks involved in participating in the activities of the Campground or while attending the Premises. I/We have read this document in its entirety and fully understand its terms. I/We understand that I am/we are giving up substantial legal rights by signing below, including the right to sue the Releasees. I/We acknowledge that I am/we are signing this agreement freely and voluntarily and intend my signature to be a waiver and complete and unconditional release of all liability due to the negligence of the Releasees or, the inherent risks of participating in the activities of the Campground or while attending the Premises.
